New Delhi: The Election Commission Thursday will resume hearing the alleged office of profit case against 20 Aam Aadmi Party MLAs. This, after the Delhi High Court had in April this year, set aside their disqualification on grounds that the poll panels' recommendation in the case were "bad in law".

The panel had in April dispatched notices to all legislators, informing that Chief Election Commissioner O P Rawat and Election Commissioners Sunil Arora and Ashok Lavasa would conduct an oral hearing on the matter.
