Fire in Mumbai-bound SUV, wind blowing wads of currency helped MP Police seize Rs 1.74 crore



Police said a Mumbai-bound SUV caught fire near Bahmani village Madhya Pradesh. "When the people inside the car kept the bags on the road as part of rescue efforts, a strong gust of wind blew wads of currency into air and onto the road, attracting attention of passersby," said an official.

New Delhi. A fire in a SUV and wind blew currency from bags kept inside police in Seoni district of Madhya Pradesh seized Rs 1.74 crore, an official said Monday.

According to report in Press Trust of India (PTI), the SUV caught fire near Bahmani village, which damaged Rs 1.50 lakh rupee denomination notes.

When the people inside the car kept the bags on the road as part of rescue efforts, a gust of wind blew wads of currency into air and onto the road, attracting attention of passersby, said Superintendent of Police Kumar Prasad. "The incident took place on Sunday evening. On being alerted, a police team rushed to the spot. The people apprehended seized Rs 1.74 crore cash from the SUV. They carried gold from Mumbai to Varanasi. The instructions of a trader," PTI quoted an official as saying.

The accused had hid the currency in a chamber under the vehicle's bonnet, etc, and the fire may have started because of a short circuit, the SP said. "The three persons in the car escaped. The passersby spotted the cash, but were not able to recover it. They were helped by Kurai police on national highway. The three, identified as Sunil Verma, Gyas Babu (42) and Hariom Yadav, are residents of Uttar Pradesh, and were carrying Rs 1.74 crore cash in a chamber under the vehicle's bonnet, etc, and the fire may have started because of a short circuit, the SP said.

The three persons in the car escaped. The passersby spotted the cash, but were not able to recover it. They were helped by Kurai police on national highway.
