To apply for Shiv Chhatrapati State Sports Award Extension till February 20

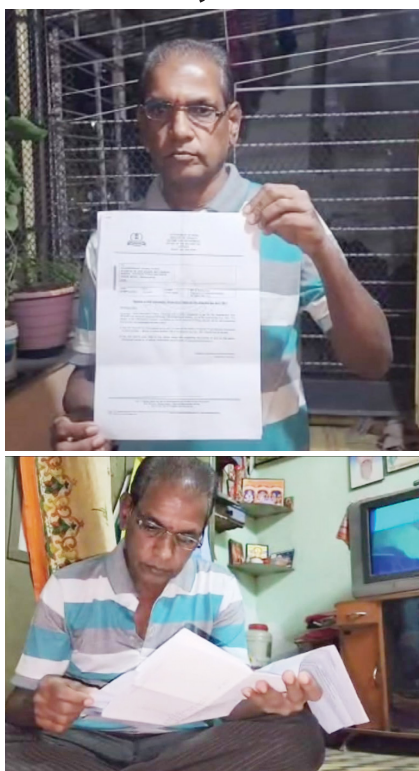

Income tax send Rs.1Crore 14 lakh notice to common citizen in Kalyan...

Kalyan: ChandrakantVarak, a resident of ThankarPada in Kalyan, was sent a notice of Rs 1 crore 14 lakh by the Income Tax Department. Varak is shocked to see this notice.Varak lives in Durganagar in Thankarpada. He works as a housekeeper in a courier company in Thane. He and his sister are the only members of the family. Varak receives a monthly salary of barely Rs 10,000 from his company. His annual income is 1 lakh 20 thousand rupees. As usual, when he left home to go to work in Thane, he received the income tax notice. This notice was for an amount of one crore 14 lakh rupees.In this notice, it was mentioned that a transaction of Rs 1 crore 14 lakh has been done on his PAN card. He read the notice many times. But seeing the transaction of the mentioned amount in it, they were shocked. Their condition was completely confused. As soon as he received this notice, he rushed to the Income Tax office. At that time, the officials of that place also explained the content mentioned in the notice to them and there is a transaction of Rs. 1 crore 14 lakhs from the PAN card. So Varak advised to go to the police station and lodge a complaint. But Varak
